RTS POS Overview

The refactored RTS POS is a web-based application designed to process vehicle registrations, titles, and temporary permits for Texas motorists. RTS POS provides functions for cash accounting, funds allocations, and a full audit trail along with inventory control for license plates, windshield/plate stickers, and temporary permits.

Enhancements in RTS POS 13.0

RRTS-24012 Added Validation of the USDOT Number to Prevent Issuance of a 72-Hour or 144-Hour Permit for Specific Vehicle Types

TxDMV issues 72-Hour Permits and 144-Hour Permits for the movement of a laden truck, truck-tractor, trailer, semitrailer, or a motor bus on the highways of Texas. Users can purchase these permits online through webPERMITS or in person at a county tax assessor-collector office or TxDMV office.

To aid in the detection of fraud, validation of the VIN and comparison of the USDOT number against the zip code and/or email address was added to verify eligibility for 72-Hour Permit or a 144-Hour Permit. The USDOT number is a unique identifier that provides information about a commercial transportation business.

In addition, the hours of availability to purchase these permits online through webPERMITS is now limited to 6 AM to 11:59:59 PM CST. The system is unavailable from 12 AM to 5:59:59 AM CST.

Legislative Enhancements in RTS POS 13.0

RTAC-165 Added Multiple Address Verification for Vehicles (SB 876)

If a vehicle record contains more than one address, RTS considers all address fields (**Renewal Notice Address**, **Owner Address**, **Vehicle Location Address**) simultaneously to determine if the processing county matches any county returned from the address validation. **Note:** Only zip codes from all available addresses are used to return associated counties.

- If a zip code falls in multiple counties and none of the counties match the processing county, then the system uses the first county returned in priority order of renewal recipient address, owner address, or vehicle location address as the county of residence. The user has the ability to override the county of residence as appropriate for the transaction.
- If the processing county matches any of the counties returned, the county of residence is populated with the processing county. **Note:** If the county of residence is modified after this return, the Transaction Authorization CTL003 screen will require a supervisor's username and password, which must be entered to continue with the transaction.



RTAC-168 Added a Check of the Address on a Dealer's License (SB 876)

RTS checks the dealer's license for the county associated with it regardless of the dealer's license status.

RTAC-169 Added Validation of Lienholder Addresses (SB 876)

RTS will determine the counties associated to all lienholders added to the transaction using only the zip codes. If more than one county is returned from the address validation for any of the lienholders added to the transaction, RTS compares the processing county to all counties that are returned.

- If the processing county is the same as any of the counties returned for any of the added lienholders, the user can complete the transaction as a statutorily required scenario.
- If not, the systems must continue to determine if the transaction is statutorily required or willing and allow processing accordingly.


RTAC-170 Added Verification of Dealer Addresses for Out of County

If a dealer license has more than one county associated to the physical address, RTS compares the processing county to each county returned.


- If the processing county is the same as any of the counties returned, the user can complete the transaction as a statutorily required scenario.
- If not, the system must continue to determine if the transaction is statutorily required or willing and allow processing accordingly.
