

## Texas License Plate Changes: Guide for Law Enforcement

Effective July 1, 2025, Texas is eliminating most paper temporary tags and transitioning to metal license plates to enhance security, prevent fraud, and strengthen traffic enforcement. Law enforcement officers should be aware of these changes when encountering Texas-registered vehicles. Law enforcement will begin seeing four new Texas metal plate types on the road.

### Paper Temporary Tags Will No Longer Be Issued (Effective July 1, 2025)

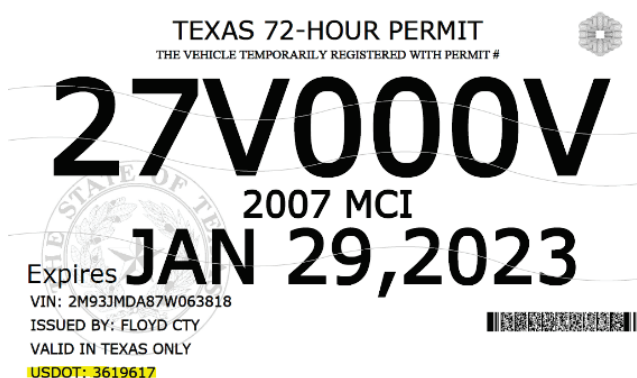

◆ Paper tags issued prior to July 1, 2025, will remain valid until expiration.  
For example, a Buyer's Temporary Tag issued June 30, 2025, will expire August 29, 2025.

## Metal Plates Replacing Paper Tags (Effective July 1, 2025)

	<b>General Issue License Plate</b> <ul style="list-style-type: none"><li>• Issued by Texas dealers to buyers at the time of sale as a replacement for paper Buyer's Temporary Tags.</li><li>• Must be properly secured on the front and rear of the vehicle.</li><li>• Buyers must keep their Buyer's Receipt in vehicle until registration is complete and the windshield sticker is received and affixed.</li><li>• Plate validity can be confirmed by law enforcement through TLETS/NLETS.</li></ul>
	<b>Dealer Temporary License Plate</b> <ul style="list-style-type: none"><li>• Issued by TxDMV to dealers for business-related uses <u>only, not personal use</u>.</li><li>• Replaces Vehicle Specific &amp; Dealer Agent paper tags.</li><li>• Used for transit to/from dealer to dealer, auction, mechanic, etc.</li><li>• Used for loaner cars and test drives.</li><li>• Used for vehicles used by a charitable organization.</li><li>• Must be securely displayed on the rear of the vehicle (not in the window) and have month &amp; year expiration stickers.</li><li>• Does not replace existing Dealer Metal Plate which can be used for dealer personal use.</li><li>• Plate validity can be confirmed through TLETS/NLETS.</li></ul>
	<b>Out-of-State Buyer License Plate</b> <ul style="list-style-type: none"><li>• Issued by Texas dealers when selling vehicles to non-Texas buyers.</li><li>• Valid for 60 days.</li><li>• Must be securely displayed on the rear of the vehicle (not in the window).</li><li>• Plate validity can be confirmed by law enforcement through TLETS/NLETS.</li></ul>
	<b>Temporary Registration License Plate</b> <ul style="list-style-type: none"><li>• Issued by TxDMV or Texas county tax offices for temporary registration needs.</li><li>• Replaces 30-Day and One Trip paper permits.</li><li>• Must have expiration stickers affixed and be securely displayed on the rear of the vehicle (not in the window).</li><li>• Plate validity can be confirmed by law enforcement through TLETS/NLETS.</li></ul>
	<b>Buyer Provisional License Plate</b> <ul style="list-style-type: none"><li>• Issued by Texas dealers when a specific plate type is not available in the dealer's inventory (such as farm or ISA plates).</li><li>• Must be securely displayed on the rear of the vehicle (not in the window).</li><li>• Valid until 7 days after a permanent plate is assigned.</li><li>• Plate validity can be confirmed through TLETS/TLETS.</li></ul>
