

# Time Permit Curfews

**Effective Date:** December 11, 2023

**Permit types affected:**

**30/60/90 day:** Length or Width

**Quarterly:** Hubometer

**Reason for this document:** The Texas Department of Transportation (TxDOT) recently changed some curfew movement restrictions. Therefore, the Texas Department of Motor Vehicles (TxDMV) created this document so existing permit holders can print out a single document to attach to existing permits that may include outdated curfew movement restrictions. As TxDOT modifies curfew movement restrictions, TxDMV will publish the modified restrictions on its website for each TxDOT district, and we will attempt to create updated versions of this document. Permit holders are responsible for obtaining current curfew and movement restrictions at [www.TxDMV.gov](http://www.TxDMV.gov).

**For oversize/overweight permits issued by TxDMV prior to the effective date listed above, the following curfew movement restrictions replace any curfew movement restrictions listed on the permit and are in effect until amended or until the permit expires, whichever occurs first. All curfew movement restrictions listed below might not apply to your specific permit, but each one was added because it applies to at least one of the permits listed above. Disregard any curfew movement restrictions that do not apply to your specific permit.**
