WHAT YOU NEED TO KNOW ABOUT HOUSE BILL 718

A New State Law Effective July 1, 2025

- ★ Eliminates six (6) paper tags and permits.
- ★ Creates four (4) new metal license plates to replace paper tags and permits.
- Requires that license plates remain with a vehicle when sold or transferred.
- Requires dealers to use webDEALER to submit transactions.
- Requires dealers to submit a Vehicle Transfer Notification (VTN) at the time of retail sale or transfer.

Four New Metal License Plates



Out-of-State Temporary License Plate

- ★ For a sale involving a vehicle to be transferred out of state.
- ★ License plate expires 60 days after issuance.



Temporary Registration License Plate

- ★ Expiration sticker required month and day.
- ★ Only issued by county or TxDMV Regional Service Centers.



Dealer Temporary License Plate

- * Expiration sticker required.
- Issued by TxDMV to dealer for demos, loaners, and transport to/from auction or service.



Buver Provisional License Plate

- * Short-term use license plate.
- May be issued by a dealer if the dealer does not have the applicable license plate available for the type of vehicle the buyer is purchasing.

Changes to Buyer Tags Effective July 1, 2025



Paper Buyer Tags and Internet Down tags are eliminated effective 7/1/2025



Non-Texas residents will receive the new Out-of-State **Temporary License Plate** with a 60-day expiration

Dealers will issue metal

plates to Texas buyers at the time of sale

Changes to Dealer Tags Effective July 1, 2025

Dealer — Vehicle Specific and Agent tags are eliminated effective 7/1/2025



Dealers will be issued one new plate type, Dealer Temporary Plate, for demos, loaners, and transport to/from auction or service



Dealers may continue using their current dealer metal plates for business use after 7/1/2025

License plates will be shipped to the licensed physical location associated with your dealer's license. If you plan to change physical locations, notify the department as soon as possible. Submit an amendment application via eLICENSING to update your licensed physical location.
