



## **In-Transit Drive-a-Way Operator Business Model Affidavit**

**Instructions:** In Texas, In-Transit Drive-a-Way Operator licenses are issued by the Motor Vehicle Division of the Texas Department of Motor Vehicles in accordance with Texas Transportation Code Chapter 503. When applying for a new license, an In-transit Drive-a-way Operator must complete the below business model affidavit. Responses to these questions will assist the Motor Vehicle Division in determining eligibility for the In-Transit Drive-a-Way Operator license under Texas Transportation Code Chapter 503.

This affidavit must be completed and signed by either an owner, managing partner, or manager listed on the current application. The completed affidavit must be signed in front of a notary public. The notary public will confirm your identity, usually through your driver's license or other governmental agency-issued identification such as a U.S. Passport. After the affidavit has been notarized, upload the completed document in eLICENSING as an attachment to your sworn application.

- Texas Occupations Code § 2301.651(a)(2) allows TxDMV to deny an application or revoke a license if the applicant or license holder makes a material misrepresentation in any application;
- A person who makes a false statement in connection with applying for or renewing a license may be subject to criminal prosecution; and
- If you make a false or misleading statement you may be held criminally responsible, and your license application may be denied or license revoked.
